*RESOLVED, That there be and is hereby levied on the tax duplicate of the City of Pickerington the rate of each tax necessary to be levied within and without the ten mill limitation as follows:*


RESOLVED, That the Clerk of this Council be and is hereby directed to certify a copy of this Resolution to the Auditor of Fairfield County.
