## A RESOLUTION AUTHORIZING THE OHIO DEPARTMENT OF TRANSPORTATION TO INSTALL WRONG WAY DETECTION AT 1-70 AND STATE ROUTE 256 WITHIN THE CITY OF PICKERINGTON LIMITS

WHEREAS, the City of Pickerington as the Local Public Agency ("LPA") and the State of Ohio ("ODOT") have identified the need to install wrong way detection at I-70 and State Route 256 within the City of Pickerington limits.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PICKERINGTON, FAIRFIELD-FRANKLIN COUNTIES, OHIO, A MAJORITY OF ITS MEMBERS CONCURRING:

<u>Section 1.</u> Consent Statement. Being in the public interest, the LPA gives consent to the Director of Transportation to complete the above-described project.

**Section 2. Cooperation Statement.** The LPA shall cooperate with the Director of Transportation in the above-described project as follows:

The State shall assume and bear One Hundred Percent (100%) of all costs of the improvement.

The LPA further agrees to pay One Hundred Percent (100%) of the cost of those features requested by the LPA which are determined by the State and Federal Highway Administration to be unnecessary for the project.

<u>Section 3.</u> Utilities and Right-of-Way Statement. The LPA agrees that all right-of-way required for the described project will be acquired and/or made available in accordance with current State and Federal regulations. The LPA also understands that right-of-way costs include eligible utility costs.

**Section 4. Maintenance.** Upon completion of the described Project, and unless otherwise agreed, the LPA shall: (1) provide adequate maintenance for the described Project in accordance with all applicable state and federal law, including, but not limited to, 23 USC 116; (2) provide ample financial provisions, as necessary, for the maintenance of the Project; (3) maintain the right-of-way, keeping it free of obstructions; and (4) hold said right-of-way inviolate for public highway purposes.

<u>Section 5.</u> The City Manager is hereby directed to enter into any necessary contracts with ODOT in order to effectuate the intent of this Resolution.

Section 6. This Resolution shall take effect at the earliest time permitted by law.
