## A RESOLUTION ACCEPTING THE DONATION OF A VEHICLE FROM LINDSAY HONDA FOR USE IN THE PICKERINGTON POLICE DEPARTMENT'S DARE AND CRIME PREVENTION PROGRAMS

WHEREAS, Lindsay Honda ("the automobile dealership") desires to help teach, mentor and educate children of all ages about alcohol and substance abuse; and

**WHEREAS**, the automobile dealership has volunteered to donate the use of one (1) vehicle for the Pickerington Police Department's DARE and Crime Prevention programs; and

**WHEREAS**, this vehicle will be leased by the automobile dealership through American Honda Finance for a period of sixty (60) months; and

WHEREAS, the City of Pickerington ("City") will incur no costs for this leased vehicle beyond normal routine maintenance; and

WHEREAS, the City shall provide police radios and flashing lights for the vehicle; and

**WHEREAS**, the automobile dealership will be responsible for graphics, auxiliary equipment, lower kits and neon lights for the vehicle; and

**WHEREAS**, this vehicle will be used for the DARE program, tours, as well as in a competition for DARE cruisers; and

**WHEREAS**, the vehicle will also be used by the School Resource Officer as a mode of transportation to and from schools.

## NOW, THEREFORE, BE IT RESOLVED, BY THE COUNCIL OF THE CITY OF PICKERINGTON, FAIRFIELD-FRANKLIN COUNTIES, OHIO, A MAJORITY OF ITS MEMBERS CONCURRING:

Section 1. The donation of the vehicle from the automobile dealership is hereby accepted.

- <u>Section 2</u>. The financing for the vehicle will be done through and by agreements between the automobile dealership and American Honda Finance. The City is neither a party to the leasing agreement, nor does the City assume any responsibility under the financing agreement.
- <u>Section 3</u>. The City's only obligations regarding the vehicle will be to conduct routine maintenance and to add the vehicle to the City's fleet insurance.
- **Section 4**. If the DARE program is canceled for any reason, the vehicle will be returned to Lindsay Honda.
- <u>Section 5.</u> The City Manager is authorized to execute all documents necessary to effect the donation.
- <u>Section 6</u>. This resolution shall take effect and be in force from and after the earliest date provided by law.
